- In connection with any Hosting Services, if Customer's actual bandwidth usage in any month exceeds allotted amount, specified in Customer's contract, Customer will pay Web Shooters Kolkata any additional fees as specified in the Service Description within three (3) days of invoicing period. We do not allow BULK or MASS emailing, in our Starter and Business Linux hosting plans we restrict the emails to 50mails/hr (1200mails/day).

Resource Usage

User may not:

- Use 10% or more of system resources for longer then 90 seconds. There are numerous activities that could cause such problems; these include: CGI scripts, FTP, PHP, HTTP, etc.
- Run stand-alone, unattended server-side processes at any point in time on the server. This includes any and all daemons, such as IRCD.

Our guarantee is that our Network will be available to clients free of Network Outages, that render 100% packet loss, 99.5% of each calendar month

Network Outages or Unscheduled Downtime is any unplanned or unscheduled interruption in Service availability during which Client is unable to access the services as described in the section titled "Network Uptime" above.

A Network Outage is defined as a period in which 100% packet loss to our network is experienced, which is determined to have been caused by a problem in Web Shooters Kolkata"s Network as confirmed by Web Shooters Kolkata. Downtime or outages are measured as the total length of time of the unplanned interruption in service availability in a calendar month.

Scheduled Downtime is any Web Shooters Kolkata scheduled interruption of Services, for the purpose of network upgrades, or replacement of any equipment in order to provide for you better service.

Permissions:

Video/Audio streaming is not allowed on our servers. You can embed 3rd party service like YouTube for streaming.

Remote MySQL access is not granted, you can use PHPMyADMIN in your hosting control panel to manage MySQL database.

MySQL database size is limited to 500mb (Starter, Business, Professional) and 1gb (Expert, Unlimited).

Remote MS SQL access is granted to manage the database only, not for integration in non-hosted application on our server.

Recreation or change of hosting platform will be charged Rs.200 after 30 days of account activation.

Payment

Establishment of this service is contingent upon receipt of payment from Customer to Web Shooters Kolkata.

Hosting account will be downgraded after your clear all the dues and before the next billing cycle.

Dedicated Server

Dedicated server or Dedicated Hosting or Self-managed servers are the entire servers leased to clients.

No refund-policy is applicable for dedicated server. Also, client is himself responsible for any data loss or if any misuse happened through his server.

Domain Registration

Web Shooters Kolkata utilizes an industry standard third party Registrar for domain name registration services.
